THE CSLB IS FINALIZING RULES TO PROTECT ELECTRICAL CONTRACTOR BESS WORK – YOUR SUPPORT NEEDED

Background- Following years of effort by the industry to protect the C-10 electrical contractor's jurisdiction over battery energy storge system (BESS) work, the Contractors State License Board (CSLB) has finally promulgated regulations to limit the ability of C-46 solar contractors to install a BESS. The proposed rules will:

- Define what a BESS is for purposes of licensing;
- Clarify that BESS work falls under the purview of the C-10 Electrical Contractor license;
- Prohibit the ability of a C-46
 Solar Contractor to install a
 standalone BESS by
 clarifying that a BESS
 is NOT part of a
 photovoltaic solar energy
 system (PSES);
- Limit the size of a BESS that a C-46 Solar



Early Registration Extended until August 10th for NECA Convention - Philadelphia


