## ALL EMPLOYERS MUST SOON USE NEW I-9 FORM

Federal immigration officials just made critical changes to modernize the 1-9 employment verification process, not only announcing a new I-9 Form but providing remote verification flexibility for qualified employers that use E-Verify. The Department of Homeland Security announced on July 21 that the long-awaited new Form I-9 became available for employers to use on August 2023. and that all 1. employers *must* use the new November form by 1. 2023. # SEPTEMBER IS SUICIDE PREVENTION MONTH

Did you know that September i Suicide Prevention Month? Further, male-dominated industries tend to have more suicides. The macho, toughquy, and stoic nature of construction workers can even discourage those who are most at risk for suicide from seeking help. Men, especially white men in their early 20's through their 50's, account for the bulk of suicides. According the Bureau of Labor Statistics, 97 percent of the U.S. construction workforce is male and according to the American Foundation for Suicide Prevention, 38 percent of construction workers in the U.S. in 2018 were between the ages of 45 and 64.



Moving from jobsite to jobsite can create an environment in which workers are not as connected to their families, each other, or a workplace community. Coupled with working long or irregular hours, sleep patterns can be impacted. causing sleep deprivation and mental and physical exhaustion.

The Construction Industry Alliance for Suicide Prevention (CIASP) has created tools and resources which can be used integrate suicide to help prevention into vour company's culture as a safety and health priority! Items available include a social media toolkit, toolbox talks, posters. OSHA suicide prevention resources. QR codes for CIASP's website, and logos. NorCal NECA is also hosting a <u>Mental Health First Aid at Work</u> seminar. This seminar teaches employees how to identify, understand and respond to signs and symptoms of mental health and substance use challenges encountered in the workplace. 

#### Manual of Labor Units Seeking Member Participation


